Course name: Sources of Obligation	Course identification: Law 112
Pre-requisite: Law 111	Level:2nd year/ Specialty compulsory requirement

This course studies the theory of obligation and their voluntary sources. The study focuses more on contract, unilateral will, injurious and beneficial acts in accordance with the Jordanian Civil Code and Islamic Jurisprudence.

Course Objectives:

This course aims to:

1- Provide students with the basic as well as advanced knowledge of the sources of obligation in Jordanian Law.

2- Develop students cognitive and practical skills through applying the theoretical knowledge of the sources of obligations to practical situations.

3- Enhance and develop students' writing skills through preparing legal research papers, reports and essays on the theory of obligation.

Learning Outcomes:

At the end of this course, a student passing the course should be able to:

1- Understand the basic principles and concepts of obligation in the Jordanian Law and relevant judicial applications.

2- Demonstrate capacity to apply theoretical knowledge to real and hypothetical cases involving the sources of obligation.

3- Demonstrate the capacity to find logical solutions supported by legal reasoning for real and hypothetical problems.

Course name: Legal studies in English	Course identification: Law 190
Pre-requisite: Law 111	Level:2nd year/ Specialty compulsory requirement

This course seeks to introduce the student to English legal terminology, which corresponds to Arabic legal terms. In order to maximize the benefit of the course, these terms are taught through studying materials in English about the definition of law, its various branches, the theory of right and its classification, and the definition of the obligation and its various sources.

Course Objectives:

This course aims to:

1. Provide students with knowledge of the basic legal terminology found in various areas of Law.

2. Clarify various concepts, terms and legal systems.

3. Develop student's cognitive skill and ability to deal with legal texts and documents in English in addition to enabling him/her to use basic legal expressions in practical areas.

Learning Outcomes:

At the end of this course, a student passing the course should be able to:

1. Adequately use various English legal terminologies in different areas of Law.

2. Use, analyse, and interpret English legal texts and documents.

3. Use the English language as a means of expressing legal ideas in different areas of law.

Course name: Effects of Obligations	Course identification: Law 213	
Pre-requisite: Law 112	Level: 2nd year/ Specialty compulsory	
	requirement	

This course examines the effects of obligations, including the definition of natural and legal obligation, compulsory enforcement of the obligation (specific performance and damages) in addition to the ways of protecting the rights of the creditor. It also concentrates on the descriptions of the obligation: the condition, the term, variety of objects of obligation, alternative and elective obligations, positive and negative joint liability, positive and negative solidarity and the indivisible obligation. The course covers the transfer of obligation: assignment of right and assignment of debt. At last it deals with the discharge of the obligation: by performance, performance and subrogation, renovation, and the lapse of time limitation without performance.

Course Objectives:

This course aims to:

1- Provide students with knowledge of basic and advanced principles and concepts related to the effects of obligation in Jordanian legislation.

2- Provide students with knowledge of the voluntary and compulsory forms of fulfillment of obligations.

3. Enhance students' cognitive and practical skills in solving problems and applying theoretical knowledge to actual cases.

Learning Outcomes:

At the end of this course, a student passing the course should be able to:

1- Demonstrate specialized knowledge of the rules for executing obligations in voluntary or compulsory means.

2- Find legislative texts relevant to the effects of the obligation, analyses, interpret and evaluate them.

3- Apply theoretical knowledge to frequent problems and work on finding logical solutions to real and hypothetical problems.

Course name: Company Law and Bankruptcy	Course identification: Law 222		
Pre-requisite: Law 121	Level:2nd year/ compulsory requirement	Specialty	

This course includes a study of the general provisions of companies, the historical development of companies, the definition of the company, the conditions of the formation of companies, the types of companies in accordance with the Jordanian Companies Law, whether companies of persons (general partnerships, limited partnerships, silent partnerships) and companies of capital (public shareholding companies, private shareholding companies, company limited by shares, limited liability companies), foreign companies, and the governance and termination of companies. The course also involves a general study of bankruptcy, its conditions and consequences, and the judicial settlement.

Course Objectives:

The course aims:

- 1- To provide the student with knowledge of the general provisions of commercial companies, their types, formation, governance, termination and liquidation.
- 2- To give the students an opportunity for advanced knowledge and understanding of the rules governing each type of companies.
- 3- To introduce the students to general knowledge of the basic concept of bankruptcy.
- 4- To provide the students with opportunities to improve analytical and cognitive skills through reviewing legal texts and jurisprudence.
- 5- To stimulate debate and discussion among students to improve their argumentation skills.

Learning Outcomes:

- Describe the differences between the types of companies and the rules governing them and their registration process at the Companies Controller Department.
- Demonstrate sufficient knowledge of the practical aspects of company law through presenting court decisions and practical examples.
- Explain the concept of bankruptcy, its provisions, and its consequences for the debtor, the creditors, and third parties.

The Course deals with the subjects of international law (States, organizations and individuals). It also deals with the definition of the state and its fundamental elements; authority, people and territories (land, sea, air). The course includes the definition of international organizations and distinguishes them from non-governmental organizations. The course covers individuals and when they may be considered as a subject of international law in terms of enjoyment of human rights and the system of criminal responsibility. It deals with the available methods of disputes resolution or settlement.

Course Objectives:

This course aims at the following:

1 –Provide the student with advanced knowledge of the subjects of the international law.

2- Enable the student to distinguish between subjects of public international law and the role of each one.

3- Develop students' skills in writing and preparing articles, reports and research papers on public international law.

Learning Outcomes:

At the end of this course, a student should be able to:

1- Demonstrate advanced as well as specialized knowledge of the subjects of international law.

2- Write research papers and reports in a scholarly manner.

Course name: Crimes against persons	Course identification: Law 242		
Pre-requisite: Law 141	Level:2 nd year/Specialty requirement	compulsory	

This course includes a study of the crimes against man and its integrity, like murder, manslaughter, intentional and non-intentional physical assault, abortion, and crimes against honor, like rape, sexual harassment, actions offending against modesty, and adultery. The course also covers crimes against freedom, like abduction, unlawful detention, threatening, trespass against homes. The course also covers crimes against personality, like libel, slander, and defamation.

Course Objectives:

This course aims to emphasize the protection of life, integrity of man's body, honor, and freedom, and to stimulate discussion over the criminal law, to examine and explain the criminal law in a comparative approach to discern weaknesses and strengths of the Jordanian criminal law, and to identify areas for legislative reform, to enhance the public sense of satisfaction of justice and legal equality *vis*. the individual and the community. This, in turn, can further the importance of security, stability, the respect for the rule of law, and the significance of all of that for economic and investment development. This course also aims to improve the thinking and analytical skills of the students at the theoretical level of the criminal law.

Learning Outcomes:

- 1- Define the crimes against persons, and mention the elements and characteristics of each crime.
- 2- Differentiate between murder and manslaughter, complete and incomplete attempt and physical assault, in a given set of circumstances of the case and the criminal.
- 3- Differentiate between murder, intentional physical assault, and assault leading to death.
- 4- Differentiate between murder and abortion causing death.
- 5- Identify abortion crimes with serious sentence or reduced sentence.
- 6- Differentiate between the crimes of adultery, rape, and enticement.
- 7- Characterize crimes as rape and crimes against honor depending on a given set of circumstances of the case and the criminal.
- 8- Differentiate between crimes against honor and crimes offending against modesty.

Course name: The Jordanian Constitution	Course identification: Law 252		
Pre-requisite: Law 151	Level:2nd year/ Spe compulsory requirement		

This course studies the constitutional system in Jordan since the establishment of the Jordanian emirate until this time, and an evaluation of the constitutions of 1928, 1947and 1952. The course deals with the constitutional paradigm in Jordan particularly in terms of the development of the Jordanian political system including the legislative, executive and judicial branches of government.

Course Objectives:

1. Provide students with the advanced knowledge about the Jordanian Constitutional Law, its origins along with constitutional history of the Hashemite Kingdom of Jordan.

2. Develop students' cognitive and practical skills in understanding the political system of Jordan.

3. Develop students' skills in writing and preparing articles, reports and research papers on topics relating to the Jordanian Constitutional Law.

Learning Outcomes:

The student passing this course should be able to:

1-Understand the basic principles and concepts of the political and constitutional system in Jordan.

2- Demonstrate advanced as well as specialized knowledge in all the topics relevant to the Constitutional Law and authorities mentioned in the constitution.

3- Analyze and interpret constitutional provisions.

4- Describe the various institutions that are linked to the Constitutional law including the Parliament, the constitutional court, and government.

Course name: Electronic legislations	Administration	on Course identification: Law 262		
Pre-requisite: Law 161		Level:2nd	year/	Specialty

This course deals with the definition of E-administration and its characteristics and goals .The course also includes the evolution of the administrative organs technically. It concentrates on the E-administrative decision and E- administrative contracts. Besides, the course deals with the ways of protecting E-administration

Course Objectives:

This course aims at the following:

1- Provide the student with knowledge of the basic principles of the topic of electronic administration

2- Develop students' skills in writing and preparing articles, reports and research papers on electronic administration legislations.

Learning Outcomes:

At the end of this course, a student should be able to:

1- Demonstrate advanced as well as specialized knowledge in all the topics of electronic administration legislations.

2- understand electronic administrative contracts.

3- Write research papers and reports in a scholarly manner.

Course name: Finance and Taxation	Course identification: Law 271		
Pre-requisite: Law 161	Level:2nd year/ Specialty compulsory requirement		

This course discusses the concept of public finance, the financial role of the government and development thereof, in addition to the general budget in terms of its preparation, principles, rules, legal systems and types. It also deals in detail with what is known as expenditures and public revenues. Besides, it explains the main sources of these revenues which are public properties, fees and taxes. The course covers also the Income tax in Jordan.

Course Objectives:

This course aims at the following:

- 1- Provide students with basic and advanced knowledge of the Jordanian financial law.
- 2- Prepare students for legal technical training in the area of taxation procedures.

Learning Outcomes:

At the end of this course, a student should be able to:

- Demonstrate advanced and specialized knowledge of the Jordanian financial legislation and its judicial applications.
- Identify expenditures and explain their social and economic impact.
- Describe the procedures for approving and monitoring the public budget.
- Write research papers and reports in a scholarly manner.

Course name: Named Contracts 1	Course identification: Law 314		
Pre-requisite: Law 213	Level:3nd year/ Specialty compulsory requirement		

This course involves an analytical study of the named contracts under the Jordanian civil code. The course examines the nature of the contracts and the way the legislator classifies them. The study focuses on the detailed rules of the sale contract as one of the contracts transferring ownership, and the lease contract as one of the contracts involving usufruct. There is an elucidation and definition of each type of contract along with its pillars, and distinguishing it from others, and its effects insofar as the obligations and rights of the parties within the stipulations of the civil code and the landlords and tenants law.

Course Objectives:

This course aims to:

1. Provide students with basic as well as advanced knowledge regarding legal rules in nominated contracts.

2. Develop student's cognitive skills in analyzing legal as well practical texts in composing and formulating nominated contracts.

3. Enable students to work with a team spirit and communicate effectively with others and rapidly respond to the latest developments.

Learning Outcomes:

At the end of this course, a student will be able to:

1- Display advanced knowledge in legislative decisions related to Nominated Contracts in the Jordanian Law.

2- Apply specialized theoretical knowledge to actual and presumed situations regarding Nominated Contracts.

3- Find logical solutions to practical situations of various sources of law.

Course name: Lobar Law and Social Security	Course identification: Law 315		
Pre-requisite: Law 213	Level:3nd year/ compulsory requirement	Specialty	

This course includes a study of Labor Law, its characteristics, historical development, its independency and scope of application. It also includes the identification of Social Security Law, its importance, development, scope of application, insurance against Work-related injuries and occupational diseases, insurance against aging, disability, death insurance and temporary disability, comprehensive health insurance, family grants and insurance against un-employment.

Course Objectives:

- 1- Identification of the individual and collective labor contracts by the student.
- 2- Identification of Social Security Law and the rules of insurance against work injuries.
- 1- Provide the student with thinking and analytical skills.

Learning Outcomes:

The student will be able after finishing this course to:

1- Recognize the accurate rules that govern individual and collective labor contracts.

2- Recognize the accurate rules that govern Social Security Law, in particular the rules relating to work related injuries.

3- Apply law to facts correctly.

This course includes a study of the provisions of commercial papers, their definition, types, functions, and history. It covers detailed study of the rules governing each type, namely: the bill of exchange, checks, and the promissory note. The course includes the expiration of the obligation arising from a commercial paper. The course also includes the general principles of banking transactions, including the opening, closing, operating of bank accounts, bank transfer, securities deposit, deposit boxes, and credit facilities, like letters of credit, documentary credits, bank guarantees, and discount of commercial papers.

Course Objectives:

This course aims:

- 1. To provide the students with knowledge of the general provisions of commercial papers, their definition, function and creation.
- 2. To introduce the students to the legal rules of each type of commercial papers in detail.
- 3. To introduce the students to a general study of the banking transactions to identify their types.
- 4. To provide the students with opportunities to improve analytical skills through reviewing legal texts and jurisprudence.
- 5. To stimulate debate and discussion among students to improve their argumentation skills.

Learning Outcomes:

- 1- Describe the differences between the types of commercial papers and the provisions governing them.
- 2- Demonstrate knowledge of different types of banking transactions, their rules, and practical aspects.
- 3- Understand the practical procedures of commercial papers and banking transactions through reviewing court decisions and practical cases.

Course name: Crimes against property	Course identification: Law 343
Pre-requisite: Law 242	Level:3nd year/ Specialty compulsory requirement

This course covers different forms of theft and related crimes, like the crime of dealing in stolen properties, forceful procurement of documents and signatures, extortion and blackmailing, use of third party's property unlawfully, and concealment of stolen properties. The course also includes the crime of fraud and related offences like exploiting minors or persons lacking capacity, fraud against creditors through disposing of property, concealment of information, and issuing non-bankable checks. The course also studies the crime of disposing with a property possessed accidentally.

Course Objectives:

This course aims to emphasise the protection of man's will and property and the material rights among people and to enhance the public sense of satisfaction of justice and legal equality which reinforces the security from the economic, social and political perspectives. The course also aims to contribute to the reform of legislation governing crimes against property through stimulating discussion over the crimes against property to discern weaknesses and strengths of the Jordanian criminal law, and to identify areas for legislative reform. This course also aims to improve the thinking and analytical skills of the students at the theoretical level of the criminal law.

Learning Outcomes:

- 1. Define the crimes against property and mention their main characteristics.
- 2. Identify the acts that are classified as theft and related crimes and to distinguish between them.
- 3. Identify the acts that constitute fraud and related crimes and to distinguish between them.
- 4. Identify the acts that constitute embezzlement and related offence and distinguish between them.
- 5. Evaluate and analyse legislative provisions governing crimes against property ad compare them with other jurisdictions to identify weaknesses and strengths in Jordanian law.

Course name: Administrative Judiciary	Course identification: Lav	v 363
Pre-requisite: Law 161	Level:3nd year/ compulsory requirement	Specialty

This course includes the principle of legitimacy, exceptions to this principles, and judiciary review over the work of the public administration. In addition, it deals with the jurisdiction of the administrative courts, formation of the court, admissible claims, preparation of an action to cancel an administrative decision, and conditions for a correct lawsuit

Course Objectives:

- Define the principle of legitimacy as a base for judicial review .
- Define the concept of judicial review over the work of the administration .
- Understand the cancellation lawsuit, its conditions and procedures .
- Study the competency of the court of administrative judiciary as provided for in the law.
- Define the types of illegality that may affect the administrative decision .
- Define the legal value of the rulings issued by the administrative judiciary.
- Define the guarantees for executing the decisions of the administrative judiciary .
- Define evidences accepted before the administrative judiciary.
- Define the ways of challenging the rulings of administrative judiciary.

Learning Outcomes:

After finishing this course, the student will be able to

- Understand the principle of legitimacy and its exceptions.
- Understand the importance of the judiciary review over the work of the administration.
- Understand the challenges that affect the efficiency of judiciary review over the work of the administration.
- Define the features of the judiciary review over the work of the administration, and understand the point of weakness.
- Define solutions to the points of weakness.
- Ability to analyze the features of the judiciary review over the work of the administration, and discover the points of weakness.

Course name: Real Rights	Course identification: Lav	w 417
Pre-requisite: Law 314	Level:4nd year/ compulsory requirement	Specialty

This course includes studying original real rights, with focus on property right in general, then the legal grounds for acquiring ownership, and the rights derived from ownership. It includes also collateral rights *in rem*, which are security mortgage, possessive mortgage and charges.

Course Objectives:

This course aims to:

1- Provide the student with deep knowledge and detailed study of real rights, the original and the collateral ones.

2- Enhance and develop the student's understanding of the practical aspects of legal rules.

3- Enhance the ability of the students to conduct legal research according to the academic methodology.

Learning Outcomes:

The student will be able after finishing this course to:

- 1- Identify accurately the fundamental rules of real rights under the Jordanian Law.
- 2- Apply law to facts correctly.
- 3- Compare between the Jordanian law and other laws.

Course name: Private International Law	Course identification: Law 418
Pre-requisite: Law 314	Level:4nd year/ Specialt compulsory requirement

This course deals with identification of private international law and its topics, legal nature of its rules; it also includes studying conflict of laws and the conflict of international judicial jurisdiction.

Course Objectives:

This course aims to identify the importance and the content of private international law, as well as studying the general doctrine in conflict of laws, besides, theoretical and practical study of the Jordanian rules of attachment in relation to private international relationships that includes a foreign element, it aims also to study the criteria of Jordanian international judicial jurisdiction and executing the foreign courts' rulings.

Learning Outcomes:

After passing this course the students should be able to: identify the topics of private international law, its nature, characterizing the legal facts and deal with different rules of attribution and apply them to the facts and legal relationships, besides his ability to define Jordanian international judicial jurisdiction through the jurisdiction criteria, and then understand the conditions and procedures needed for executing the foreign judgments by domestic judiciary.

Course name: Insurance Contracts	Course identification: Lav	v 419
Pre-requisite: Law 314	Level:4nd year/ compulsory requirement	Specialty

This course includes identification of insurance, its historical development, formation of insurance contract, types of insurance: mandatory and optional, insurance of persons (insurance against personal injury and harm or unemployment or life insurance), insurance against losses (theft, fire and liability).

Course Objectives:

- 1. Provide the student with a thorough and detailed study of insurance contract.
- 2. Enhance and develop the student's understanding of the practical aspects of legal rules.
- 3. Enhance the ability of the student to draft insurance contract.

Learning Outcomes:

After finishing the course, the student will be able to

- Recognize accurately the rules that govern insurance contracts.
- Apply legal rules to facts correctly.
- Compare between the rules of Jordanian law and other legislative approaches.

Course name: Law of Civil Procedure	Course identification: Law 420	
Pre-requisite: Law 213	Level:4nd year/ Specia compulsory requirement	lty

This course covers the definition of the law of civil procedure and the structure of the Jordanian judiciary, types of courts, levels of litigation, and the status of judges and court clerks, the rules of court jurisdiction in international cases, residual jurisdiction, value-based jurisdiction, geographical jurisdiction, subject matter jurisdiction, and the theory of the action, its proceedings, its interruption, and judgments and means of appeal.

Course Objectives:

This course aims to provide the student with knowledge of the law of civil procedure, its nature and characteristics, the structure of the judiciary, the jurisdiction of courts, the principles of action and its admissibility. The course also aims to improve the student's skills in applying procedural rules by which substantive rights and rules are asserted.

Learning Outcomes:

- 1. Recognize the concept of the law of civil procedure as a procedural law and its role vis. substantive rules of law.
- 2. Demonstrate the capacity to apply procedural rules by which substantive rights and rules are asserted.
- 3. Demonstrate capacity to solve theoretical and practical questions about the procedures to bring and try an action up to a final judgment.

Course name: Law of Electronic Commerce	Course identification: Lav	v 425
Pre-requisite: Law 222	Level:4nd year/ compulsory requirement	Specialty

This course covers the concept of electronic commerce and its characteristics, the mechanisms of contracting through modern means of telecommunication, and the legal problems in this field. These problems include the authenticity of electronic means of telecommunication as a means of proof, dispute resolution, determining the applicable law and judicial jurisdiction. Also, the course covers possible means for the protection of consumers in electronic contracts, the effects of an electronic contract and the obligations arising under it, and other relevant issues.

Course Objectives:

This course aims:

- 1. To provide the students with sufficient knowledge of electronic commerce.
- 2. To provide the students with knowledge of the means of contracting via modern telecommunications.
- 3. To enable the student to determine the applicable law and the competent court in respect of disputes connected with contracts of electronic commerce.

Learning Outcomes:

- 1. Recognize the basic concepts and provisions relating to electronic commerce.
- 2. Apply the legal rules to a set of facts correctly.
- 3. Compare the rules of Jordanian law with modern legislative trend

Course name: Intellectual Property Rights	Course identification: Law 427	
Pre-requisite: Law 213	Level:4nd year/ Specialt compulsory requirement	У

This course covers a general study of the rules of intellectual property. It includes the explanation of the concept of intellectual property and the principles and rules that have been settled to recognize and protect these rights as distinct rights. The course examines industrial intellectual property rights, like patents, trademarks, industrial designs, trade secrets, integrated circuits design, and new plant classes. The course also studies the right of the author and allied rights.

Course Objectives:

This course aims:

- 1. To provide the students with knowledge of the concept of intellectual property and its history and the basic principles and rules enshrined in international conventions and national legislation.
- 2. To provide the students with opportunities to improve skills through reviewing and analysing legal texts about industrial and litrary intellectual property.
- 3. To provide the students with knowledge of the right of the author and allied rights and pertinent contracts.

Learning Outcomes:

- 1. Explain the legal regime of industrial and literary intellectual property.
- 2. Identify the elements of different kinds of intellectual property and demonstrate understanding of the provisions of each of them.
- 3. Apply the legal rules to factual situations involving intellectual property using court decisions and jurisprudence.
- 4. Analyse the provisions of international conventions on intellectual property and assess the consistency between them and national legislation.

Course name: Information Technology Crimes	Course identification: Law 445		
Pre-requisite: Law 343	Level:4nd	year/	Specialty
	compulsory	requireme	nt

This course covers criminal conduct involving unauthorized access to electronic sites or information systems, bringing or disseminating or using programs without permission, receiving or intercepting or spying on materials transmitted via the internet or any information system, obtaining without permission or illegitimately using data or information relating to credit cards or used in the execution of electronic financial and banking transactions, transmitting or publishing legible, audio or visual material of obscenity or sexual exploitation of persons below the age of 18, preparing or storing or processing or displaying or printing or publishing or promoting immoral works or activities, using the internet to promote prostitution.

Course Objectives:

This course aims to emphasise the protection of institutions, individuals, and national security against information technology crimes and the need for preserving confidence in using electronic systems. The course aims to explain the elements of each one of the relevant crimes that have emerged with the advent of information systems and the internet, and to identify gaps in the legislation governing conventional crimes. The course also aims to provide the student with basic and advanced skills to deal with the legal aspects of the use of the computer, and the concepts and terminology of information technology, and to use electronic resources to obtain legal information and recognize information systems serving legal education and practice.

Learning Outcomes:

- 1. Define the crimes of information technology and mention their characteristics.
- 2. Explain the following concepts: information system, data, the internet, electronic sites, authorization, programs.
- 3. Define the crime of unauthorized access to, or exceeding the limits of authorization to access, an electronic site or information system.
- 4. Define the reception , interception, spying in respect of material transmitted via the internet or an information system.
- 5. Compare certain legal provisions governing information technology crimes with other jurisdictions to identify weaknesses and strengths of the Jordanian law.

Course name: Law of Criminal Procedure	Course identification: Law 446	
Pre-requisite: Law 213 + Law 343	Level:4nd year/ Specia compulsory requirement	ty

This course covers the definition of the law of criminal procedure and the public prosecution in accordance with the relevant legislative provisions. The course explains the public prosecution in terms of its parties, namely the accused person and the public prosecutor, the stages of the proceedings, the competent authority to bring criminal proceedings, the manner of commencing prosecution, and the lapse of the criminal action, and the means of recourse against sentences. The course examines the civil action as ancillary to the criminal action in terms of its parties, conditions, the manner to institute the civil actions, and its lapse and means of appeal of the judgment. The course includes the main theories of criminal procedure, like jurisdiction, nullity, and proof.

Course Objectives:

This course aims to explain available means of prosecution of criminals and the enforcement of punishment against them. The course also aims to highlight the relevance of speedy proceedings for the general and specific deterrence, striking balance between the public interest in expeditious prosecution and quick punishment and the interest of the individual in exercising the right of defense.

Learning Outcomes:

- 1. Define the law of criminal procedure and mention its characteristics.
- 2. Explain the concept of criminal action, its parties, stages, the competent authority to commence ot, prosecution, its end and appeal against sentences.
- 3. Explain the basic theories of criminal procedure, namely the jurisdiction, nullity, and proof, and to recognise the guarantees of the accused in the phases of detection, investigation, and trial.
- 4. Simulate the role of law enforcement agents and the attorney general in drafting indictemtn, decision of charges, and an application to release suspects on bail.
- 5. Draft a decision to prevent prosecution, drop charges, and modify the criminal description of the charge.
- 6. Simulate the judge's role in drafting decisions of cinviction, acquittal, non-responsibility, modifying the criminal description of the act, or to stop the prosecution or dimsiss the criminal action.

Course name: Law of Evidence	Course identification: Law	486
Pre-requisite: Law 420	Level:4nd year/ compulsory requirement	Specialty

This course defines judicial proof, its systems, the nature of evidentiary rules, the subject matter of proof, and conditions of evidence, the allocation of the burden of proof, and the rules governing these issues. The means of proof under the Jordanian law of evidence and the procedures for using each of them. The course also covers the law of execution, the constitution and procedures of the department of execution, the adversary procedure before the department and the means of compulsory enforcement against the debtor's assets and the distribution of the proceeds of enforcement.

Course Objectives:

This course aims:

- 1. To provide the students with knowledge of evidence and procedures of execution.
- 2. To provide the students with opportunities to improve practical skills.
- 3. To provide the students with opportunities to improve writing skills through drafting reports and writing papers.

Learning Outcomes:

- 1. Define precisely the means of proof under Jordanian law.
- 2. Describe the procedures for the execution of judgments.
- 3. Apply legal rules to factual situations correctly.

Course name: Judicial Exercises	Course identification: Lav	v 490
Pre-requisite: Law 420 + Law 446	Level:4nd year/ compulsory requirement	Specialty

This course includes exercises at practical procedures of the law before different types of courts and at all levels, role playing with pertinent research and analysis of facts, writing pleadings, statement of case, case management through different stages of litigation, drafting submissions, memorials, and pleadings, exercising oral submissions, cross-examination of witnesses and experts, drafting judgments, preparing appeals, using logic and legal reasoning, and acting according to professional ethics.

Course Objectives:

This course aims to train the students in a professional manner on delivering legal services expected in the market, to enhance their self-confidence, to improve their commitment to the legal profession, to develop team work skills and communication skills in writing and orally.

Learning Outcomes:

- 1. Demonstrate writing skills in drafting statements of cases, memorials, submissions, and legal submittals involved in an action.
- 2. Act in accordance with professional ethics when delivering legal services.
- 3. Apply the knowledge of law in real and hypothetical situations.

Course name: Civil Service	Course identification: Law 263
Pre-requisite: Law 161	Level:2nd year/ Specialty optional requirement

This course studies the civil service through identifying employment systems all over the world and Jordan, it includes; methods of appointment in civil service, conditions for appointment, different situations that may accompany the servant during his service life such a, secondment, transfer, promotion, delegations, the legislative foundation for the civil servant competence, rights and obligations of the civil servant, the authority that is responsible to investigate the civil servants legal breaches, guarantees during investigation and penalties and finally the reasons for which civil service relationship is terminated.

Course Objectives:

This course aims to develop the student's ability in practical, objective, and analytical thinking, his ability to connect legal matters and solve legal problems, and the course aims to provide the students with a deep knowledge in the topic of civil service

Learning Outcomes:

Course Outcomes: (understanding, knowledge, mental and practical skills)

After finishing this course the student will be able to:

- 1- Understanding and knowledge, the student will be able to
- Understand the civil service and service competency
- Understand the methods and conditions for appointment in civil service
- Understand different situations that may face the civil servant during his service such as transfer, delegations and others.
- Understand the rights and obligations of the civil servant.
- Understand penalties that may be imposed on the civil servant for breaches committed by him and investigation for those braches as well as guarantees for fair procedures.
- Understand service competence
- Understand the termination of civil service relationship.
- 2- Mental Skills
- Analyze and criticize the legal provisions and the courts' rulings that relate to civil service.

- Be able to think correctly, brainstorm, discuss, all based on a good understanding for the topic.

Course name: Legal Writing	Methods	of	Research	and	Course identification: Law 290
Pre-requisite: La	w 213				Level:2nd year/ Specialty optional requirement

This course includes the ways to find out legal information and the methods of research, using resources of legislation and court decisions published in print or electronically. The course also covers styles of legal writing involving research papers and problem solving. This does not include contract drafting and legislative drafting.

Course Objectives:

This course aims to:

- 1. Provide the student with knowledge of the research methods.
- 2. Improve the student's thinking skills and the capacity to write in correct legal language.
- 3. Provide the student with the skills of finding legal information.

Learning Outcomes:

- 1. Identify the methods of research.
- 2. Find references and organise a bibliography.
- 3. Write a research paper in a scholarly manner.

Course name: Maritime and Aviation Law	Course identification: Law 324
Pre-requisite: Law 222	Level:3nd year/ Specialty optional requirement

This course identifies the rules of Maritime and Aviation Law; explains its topics, characteristics, history, sources, legal nature for the ship and plane, ownership, ship and plane personal such as the owner, captain, Sailors, their legal liability according to international conventions and national laws, then this course deals with exploitation of the ship and plane in transportation through lease contract or bill of lading and through transportation of persons and goods. The course also includes Maritime sales, accidents, shared maritime losses, besides ship docking and guidance.

Course Objectives:

Learning Outcomes:

The outcomes of the course include explaining the said mentioned principles that relate to Maritime trade and Aviation Law, as well as discussing, analyzing, and criticizing the legal provisions and courts' rulings with regards to Maritime and Aviation Law.

Course name: International Humanitarian Law	Course identification: Law 333
Pre-requisite: Law 323	Level:3nd year/ Specialty optional requirement

This course covers the definition of the international humanitarian law, its branches, nature, and general principles, the distinction between IHL and the law of human rights. The course includes the provisions of the four Geneva conventions of 1949, involving the status of the injured, drowned, and sick, the treatment of war prisoners, the protection of civilians, and applying these provisions to the cases of occupied Palestine, Iraq and Afghanistan.

Course Objectives:

This course aims:

- 1. To provide the student with knowledge of the basic principles and rules of the IHL.
- 2. To improve the thinking skills of the student through solving problems involving IHL.
- 3. To introduce recent developments at the international arena concerning violations of IHL.
- 4. To emphasize the necessity of the compliance with the IHL and explain the consequences of its violations.

Learning Outcomes:

- Explain the nature of the IHL.
- Debate and discuss ideas and topics of IHL and to propose solutions to issues in IHL.
- Apply the knowledge of IHL in real situations and identify violations and criticize them.

Course name: Criminology and Penology	Course identification: Law 344
Pre-requisite: Law 242	Level:3nd year/ Specialty optional requirement

This course covers the definition of criminology and penology, the importance of this discipline, its history and phases of development, and the relationship between this discipline and other criminal disciplines. The course examines the concept of crime and punishment, the criminal, methods of research in criminology, theories interpreting the crime phenomenon, social theories interpreting criminal conduct, and the relevance of internal factors like genetic factors, kinship, personal formation, illness, age, and sex. Besides, the course examines external factors like natural factors, cultural factors, economic and social factors. The course covers the study of punishment, the nature and development of types of punishment, precautionary measures and their enforcement, penal institutions and their methods of enforcement of punishment.

Course Objectives:

This course aims to promote the understanding of the phenomenon of crime to contribute to combating crimes, to discuss the internal and external factors causing crimes, like genetic factors, kinship, personal formation, illness, age, and sex. Besides, the course examines external factors like natural factors, cultural factors, economic and social factors, and to find alternative penalties of rehabilitation and correction.

Learning Outcomes:

- 1. Define criminology and penology and mention their characteristics.
- 2. Describe the history of criminology and its relationship with othe disciplines.
- 3. Understand the concept of crime and punishment under the criminal law and in criminology.
- 4. Use research tools in criminology, like empirical research, surveys, comprehensive examination of the criminal, observation, interviews, questionnairs, and case study.
- 5. Copmare biological theories and social theories interpreting the criminal conduct.
- 6. Differentiate internal and external factors causing crime.

Course name: Public Liberties and Rights	Course identification: Law 353	
Pre-requisite: Law 252	Level:3nd year/ S compulsory requirement	pecialty

This course covers the definition of basic public liberties and rights enshrined in international conventions and covenants, mainly the covenant on civil and political rights and the covenant on social, economic and cultural rights, and the universal declaration of human rights, and assesses the conformance of domestic law with them. The course includes a study of the classifications of rights and liberties and the guarantees for them and the means of their enforcement at the national level.

Course Objectives:

This course aims:

- 1. To provide the students with knowledge of the distinction between right and liberty.
- 2. To provide the students with knowledge of the kinds of rights and liberties and their classification.
- 3. To study the obligations of the state in respect of the implementation of the rules relating to public liberties and rights.
- 4. To study the guarantees of the protection of the rights and liberties of the individual

Learning Outcomes:

- 1. Analyse legal provisions and compare international conventions with domestic legislation.
- 2. Demonstrate commitment to prompting awareness of the rights and liberties of the individual.
- 3. Understand the impact of international developments on the rights and liberties of the individual.

Course name: Named Contracts (2)	Course identification: Law 415	
Pre-requisite: Law 314	Level:4nd year/ Spe compulsory requirement	ecialty

This course includes identification of some contracts that are governed by the Jordanian legislator. Therefore, the student will study three contracts, such as (donation, loan, settlement, construction, agency, bail---ext.), by shedding some light on the notion of these contracts, their formation and elements.

Course Objectives:

This course aims to:

- 1- Acquire sufficient knowledge with regard to some contracts.
- 2- Enhance and develop the student's understanding of the practical aspects of legal rules.
- 3- Develop the students' skill of analyzing legal provisions.

Learning Outcomes:

The student will be able after finishing this course to:

- 1- Identify accurately the contracts within the Jordanian Civil Code.
- 2- Distinguish between contracts
- 3- Apply law to facts correctly.

Course name: Arbitration and Alternative Dispute Resolution	Course identification: Law 429
Pre-requisite: Law 420	Level:4nd year/ Specialty compulsory requirement

This course covers the definition of arbitration and the alternative means of dispute resolution, their emergence and development, legal nature, types, and their advantages and disadvantages. The course studies the procedures and elements of arbitration, including the agreement of arbitration, the appointment of arbitrators and challenging and removing them, the arbitration procedures, interim measures during arbitration, the role of the competent court, the applicable law to the dispute, the issuance of the arbitration award, and the means of recourse against it before the competent court, and the legal effect of the award and its enforcement.

Course Objectives:

This course aims to give knowledge of : the basic principles and theories of alternative means of dispute resolution, particularly arbitration, the arbitration agreement and procedures, and the interim measures during arbitration.

Learning Outcomes:

The student passing this course should be able to critically review the relevant legislation and court decisions, solve problems, identify weaknesses and strengths in the arbitration law and the alternative dispute resolution, and to compare national legislation with foreign laws.
